Our litigation has twin goals: To represent low wage workers while at the same time taking on cutting-edge legal issues, including the enforcement of new laws that protect against gender bias. This work can include everything from initial client intake to working on a legal brief. 2. Working in our monthly pro bono legal clinic, including conducting intake and meeting with clients. 3. Drafting “know your rights” materials to distribute to low income workers experiencing gender-based discrimination, who cannot access legal representation, to assist them in navigating and/or accessing the legal system by themselves. 4. Working on projects with our not for profit partners, including providing back up legal assistance to lawyers working in organizations that represent low wage workers and training legal staff at these organizations on relevant laws protecting against gender-bias.</p>	x	x	x
