POSITION TITLE: PRINCIPAL NETWORK TECHNOLOGIST **JG: 28**

Associate Network Technologists configure complex wide area networks and install operating and application software and hardware. They resolve problems with the implementation, operation, and maintenance of communication media, computer equipment, and network design, assist local area network administrators and staff of local administrative offices to configure complex local area networks, and perform other related duties.

- **Desktop Systems Engineer:** Responsible for installing, evaluating, managing, documenting, and troubleshooting endpoints (PCs, printers, scanners, etc.) and their associated software (Windows XP/7, AntiVirus, Office Suite, etc.) on the enterprise network. Experience with Enterprise Desktop Management Platform, such as Altiris and Symantec SEP, and Windows Server OS is a plus.
- **Server Systems Engineer:** Responsible for installing, evaluating, managing, documenting, and troubleshooting networked servers in the data center.
