DISTINGUISHING FEATURES OF WORK: Case Managers I report to the Chief Clerk and Project Director and work in problem solving parts and units. Case Managers I develop treatment plans, determine intervention services, counsel participants and make recommendations to the court. Case Managers I prepare written reports and maintain case files on participants. Case Managers I may also perform other related duties.

ASSIGNMENT: Duties in the Kings Treatment Court include conducting assessments of defendants for participation in court-monitored substance abuse treatment; submitting detailed recommendations regarding defendants' eligibility to participate in treatment; referring and placing defendants in community-based treatment programs; monitoring defendants' participation in community-based treatment programs; submitting detailed updates to Court and parties regarding treatment participation; and conducting monitored urine toxicology screens.
