NYS Court Officer-Captains supervise the activities of Lieutenants, Sergeants, and other subordinate security personnel. New York State Court Officer-Captains are responsible for assisting in the local implementation of statewide security policies to meet the local circumstances of the court or facility to which the position is assigned. NYS Court Officer-Captains are peace officers, required to wear uniforms and may be authorized to carry firearms and also perform administrative and other related duties.
