They serve in a confidential capacity and work with substantial independence from supervision in units located in the Court of Claims or special parts in the Supreme Court or in County, District, Family, and Surrogate's Courts in counties entirely within cities or in counties that have populations exceeding 400,000.

**ASSIGNMENT:**

Duties include but are not limited to: conferring with and advising the Administrative Judge on complex legal issues; researching and analyzing complex legal questions and preparing opinions, reports and confidential memoranda for the Administrative Judge; acting as the subject matter expert in all areas of law under the court's jurisdiction; analyzing and preparing written interpretations of statutes and rules for the guidance of judicial and non-judicial personnel; supervising and conducting training for court attorneys, court attorney-referees and support magistrates; conducting hearings, taking testimony and reporting findings of facts to Judge.
