QUALIFICATIONS: Graduation from an accredited law school no more than three (3) years prior to appointment and admission to the New York State Bar within eighteen months of appointment.

DISTINGUISHING FEATURES OF WORK: Assistant Law Clerks are appointed in the Civil Term by Justices of the Supreme Court or are assigned to Judges designated as Acting Supreme Court Justices for one or more full terms.¹ They research and analyze legal issues raised in complex civil term motions and are responsible for preparing memoranda, drafting orders, opinions and verifying citations. Assistant Law Clerks are appointed to a one year clerkship, renewable once, and are personally appointed by the Supreme Court Justice for whom they work and serve at their pleasure.

¹ Judges who appoint an Assistant Law Clerk agree to forego the appointment of a Secretary and waive the right to such an appointment under section 36 of the Judiciary Law for the period of service for the Assistant Law Clerk.

ASSIGNMENT: This position is assigned to Justice Marcy Friedman, Acting Supreme Court Justice, New York County - Commercial Division and will commence in January 2015 or February 2015. Applicants should have experience with complex commercial litigation and/or complex financial products, and strong writing skills. Duties include, but are not limited to: legal research and drafting, conducting discovery and other conferences, and assisting with preparation for oral arguments in a wide range of commercial disputes including residential mortgage-backed securities cases, investor fraud actions, breach of contract actions, commercial mortgage foreclosures, and business torts. Additional duties include various administrative responsibilities such as scheduling cases and monitoring the docket.

GENERAL INFORMATION: The above statements are intended to describe the general nature and level of work being performed by persons assigned to this title. They do not include all job duties performed by employees in the title, and every position does not necessarily require these duties.
