Under the supervision of New York State Senior Court Attendants, Appellate Division, New York State Court Attendants, Appellate Division are responsible for maintaining order and decorum in courthouses, court buildings and grounds. They also perform various clerical, reception, messenger and other related duties. New York State Court Attendants, Appellate Division are peace officers, required to wear uniforms, and may be authorized to carry firearms.

This position will be assigned to courtrooms and court premises in the Robert Abrams Building for Law and Justice, Empire State Plaza, Albany, New York and in other court locations within the Third Department as directed by the Presiding Justice, the Clerk of the Court, or the Chief of Security, Appellate Division.
