MEMORANDUM

Re: Proposed new search warrant procedures and database.

The Office of Court Administration has developed a proposed secure statewide database for recording limited search warrant information. The new statewide database would assign a unique number to each search warrant at the time of data entry. Court clerks would enter the warrant information into a database and record certain subsequent developments related to that warrant, including the filing of a return on the warrant or the issuance of a court order relating to sealing or confidentiality. In order to apply for a warrant, the applicant would be required to complete a brief one-page "Search Warrant Worksheet" that collects basic information about the filing, i.e., the judge, contact information for the applicant and whether the warrant is public or confidential (Exh. A). The form does not request any confidential information as to the subject of the warrant and all supporting documents will remain confidential until the court directs otherwise. Current local practice regarding judicial assignment of search warrants will be continued. The proposed new statewide database and search warrant procedures would foster standardized court practices with regard to recording search warrant applications and subsequent warrant information, including whether the warrant application is sealed or has become a public record at some point after its execution.
