ONEONTA CITY COURT RECORD SEARCH & CERTIFICATES OF DISPOSITION INFORMATION

Thank you for your inquiry regarding availability of record searches and Certificates of Disposition from Oneonta City Court.

Oneonta City Court can conduct a search for local records. For criminal charges, Oneonta City Court will search for Violation level offenses and local law violations. The cost of a criminal violation search at Oneonta City Court is \$5.00 for every consecutive two year period you specify. Another option is to check with the arresting agency and obtain date of offense and charge.

Criminal History Searches (Misdemeanor and Felony level charges) in New York State, are conducted through the Office of Court Administration's Criminal History Search Unit. They can be reached at (212) 428-2810. You may wish to contact them for more specific information regarding the case in question (date and place of the offense, exact charges...) and then direct inquiries to the court of jurisdiction for the case.

Once a specific Oneonta City Court case is located, a Certificate of Disposition is available for \$5.00.

Please complete and return the enclosed form with proper payment and a SASE to expedite return of the results. If you are requesting sealed or youthful offender information, the form must be signed by the defendant and the defendant's signature must be notarized. All requests must be mailed to the Court. Faxed or e-mailed requests will not be honored.

Turnaround time for searches and Certificates of Disposition will vary, based upon the number of years requested and the nature of the media upon which the record is stored. Requests will be performed as quickly as possible while conforming to the operational needs of the court. Generally, please allow 10-15 business days for the processing of your request.
