PERMANENT COMMISSION ON ACCESS TO JUSTICE

PURPOSE

- THE MISSION OF THE PERMANENT COMMISSION ON ACCESS TO JUSTICE (THE COMMISSION) IS TO EXPAND ACCESS TO CIVIL LEGAL SERVICES AND IMPROVE ACCESS TO JUSTICE GENERALLY.
- IT PROVIDES SUPPORT FOR THE PREPARATION OF THE CHIEF JUDGE'S ANNUAL STATEWIDE HEARING TO ASSESS THE UNMET NEEDS FOR LEGAL REPRESENTATION IN CIVIL LEGAL PROCEEDINGS INVOLVING FUNDAMENTAL HUMAN NEEDS, AND IT ASSISTS IN DEVELOPING THE CHIEF JUDGE'S REPORT AND RECOMMENDATIONS TO THE LEGISLATURE AND THE EXECUTIVE ABOUT THE LEVEL OF PUBLIC RESOURCES NECESSARY TO MEET THOSE NEEDS.
- THE COMMISSION ALSO HAS ONGOING RESPONSIBILITY TO STUDY, ANALYZE AND
 DEVELOP RECOMMENDATIONS ON ALL ASPECTS OF CIVIL LEGAL SERVICES FOR LOWINCOME NEW YORKERS; TO ISSUE RECOMMENDATIONS PROVIDING FOR IMPROVED
 AND INCREASED ACCESS; AND TO COLLABORATE ON ACCESS TO JUSTICE ISSUES,
 INCLUDING EXPANDED PRO BONO SERVICES AND HELP FOR UNREPRESENTED LITIGANTS.

HISTORY

- The Commission was established in 2015 with the enactment of Part 51.1 of the Rules of the Chief Judge (22 NYCRR § 51.1). The original mandate of the Task Force was to Expand Access to Civil Legal Services in New York, formed in 2010 by then-Chief Judge Jonathan Lippman as part of a comprehensive effort to provide counsel to low-income New Yorkers in civil cases.
- Since its establishment, each year, the Chief Judge, with assistance from the Commission, holds a public hearing to assess the unmet civil legal needs of low-income New Yorkers. Based on the public hearing and its ongoing work, the Permanent Commission issues an annual report to the Chief Judge recommending initiatives to help close the access-to-justice gap in the State.
- The Chief Judge submits these annual reports to the Governor and Legislature pursuant to a 2010 Joint Legislative Resolution. The result of this process has been the implementation of multi-faceted initiatives to help bridge the justice gap—most importantly attaining the initial funding goal of \$100 million of dedicated annual State funding for civil legal services.

2024 AREAS OF FOCUS:

In consultation with Chief Judge Wilson, the Commission's focus for 2024 includes:

- 1) Access to justice barriers faced by litigants in summary proceedings in the Town and Village Courts;
- 2) Initiatives to help address the rural justice crisis;
- 3) Expanding legal roles to increase the availability of authorized professionals who can provide legal assistance;
- 4) Strengthening the capacity of legal services providers through increased use of technology, including the advancement of AI to expand access to justice

WORKING GROUPS

- Five Working Groups have been established to study the issues and make recommendations for adoption by the Permanent Commission.
- The Working Groups generally meet bi-weekly, with significant assistance from the Permanent Commission's staff counsel.
- This year, the Working Groups have invited legal providers throughout the state to present summaries of innovative programs that have been implemented in other states. The goal is to gather data to formulate recommendations to the Chief Judge for New York State.
