above-entitled estate of the deceased, by which it has been established to the satisfaction of the	
court that the place of residences of are	
unknown and cannot, after diligent inquiry, be ascertained; also, that there may be other heirs	
and next of kin of said deceased, whose names and/or places of residence are unknown and	
cannot, after diligent inquiry be ascertained, that service of the citation in the above-entitled

ORDERED, that proof of publication shall be filed with the court on or before the second day preceding the return date, in accordance with 22 NYCRR 207.7(c); and it is further

ORDERED, that appearances on the return date of the citation will occur by video conference utilizing the Microsoft Teams application, which video link may be found in the citation. If you do not have the technology to access the video link, to appear both visually and with audio sound, you must appear in-person at the courthouse, located at 18 Richmond Terrace, Staten Island, New York, to use a computer terminal to access the court; and it is further

ORDERED, that appearances may be made by the dial-in information found in the citation only if prior consent is provided by the court.
