Attorneys in this position prepare memoranda and other case materials for the Court's consideration in cases arising under the Uniform Rules for Attorney Disciplinary Matters (22 NYCRR) part 1240 and may assist the individual Justices of the Court in the drafting of Court decisions in such cases. OLP attorneys also regularly interact with the parties involved in professional matter litigation before the Court and assist members of the public with inquiries related to the regulation and oversight of the legal profession. Position may be eligible for 20% remote work as part of a pilot program; eligibility is at the discretion of the court and OLP and may be subject to change based upon the needs of the court.
