Warrant of evictions issued after Hurricane Sandy Eff. Date: December 6, 2012

BACKGROUND

Hurricane Sandy was one of the most historic and devastating storms to ever hit the Northeast region. The unprecedented damage, disruption, and impact of the hurricane disaster upon the City continues, including thousands of persons, many with special medical needs, who require shelter. Power outages, disruption of fuel, transportation, and telecommunication services also continue. In sum, the City is still responding to a major disaster and widespread emergency conditions. In light of this, we are instituting the following directive.

DIRECTIVE:

Until further notice, no warrant of eviction shall issue for premises in the zip codes and areas that have sustained severe damage due to Hurricane Sandy without:

• an affidavit or affirmation submitted by the petitioner, or the petitioner's attorney, indicating that all essential services have remained operational in the building allowing tenants to inhabit same,

or

• If to best of the petitioner, or petitioner's attorney's knowledge, essential services have been restored after having been interrupted in the building as a result of Hurricane Sandy, an affidavit must be submitted by the petitioner or petitioner's attorney stating same and, furthermore, that all essential services for the building have been restored and the respondent(s) is/are not hospitalized or has/have not passed away.
