DIRECTIVES AND PROCEDURES

Subject: Establishment of a Small Property Part
in the New York City Civil Court, Housing Part

BACKGROUND:

At its height, the Coronavirus pandemic caused a near-total cessation of operations in the Housing Part of the New York City Civil Court. Since then, the Housing Part has successfully restored many thousands of pre-pandemic cases to its virtual and in person calendars, along with a significant number of newer cases. To continue to facilitate the adjudication of cases in the Housing Part, the Court establishes a Small Property Part, which shall remain in effect until further notice.

DIRECTIVE:

Effective January 17, 2022, any matter where the premises involved is located within the five boroughs of New York City, is owned by the petitioner, and is a 1, 2 or 3 family premises is to be assigned, after an appearance in the intake or HMP part for assignment of counsel for respondent, to the Housing Part identified as the “Small Property Part”.

The person responsible for reviewing petitions for filing must review for the above criteria, paying special attention to instances where the:

- (1) Cashier accepts a new filing that meets the above criteria for Small Property, including a “Small Property Owner’s D.I.Y.” assembly; and/or
- (2) Petitioner or attorney identifies the case as being eligible for the part at the time of purchasing the index number by filing the “Request for Assignment/Transfer to the Housing Court Small Property Part” form (see Exhibit A).

Additionally, if the clerk becomes aware that a case is eligible for the “Small Property Part” or the petitioner files the “Request for Assignment/Transfer to the Housing Court Small Property Part” form requesting the transfer of a previously calendared case that qualifies for assignment to the “Small Property Part”, the clerk is to bring it to the attention of the presiding Judge so that the case can be transferred.
