

**TAMPERING WITH A WITNESS**  
**SECOND DEGREE**  
**(D Felony)**  
**(Causing Injury To Witness After Testimony)**  
**PENAL LAW § 215.12(2)**  
**(Committed on or after Sept. 1, 1982)**

The \_\_\_\_\_ count is Tampering with a Witness in the Second Degree.

Under our law, a person is guilty of Tampering with a Witness in the Second Degree when he or she intentionally causes physical injury to a person on account of such person or another person having testified in a criminal proceeding.

Some of the terms used in this definition have their own special meaning in our law. I will now give you the meaning of the following terms: “criminal proceeding,” “physical injury” and “intentionally.”

**CRIMINAL PROCEEDING** means any proceeding which (a) constitutes a part of a criminal action or (b) occurs in a criminal court and is related to a prospective, pending or completed criminal action, either of this state or of any other jurisdiction, or involves a criminal investigation.<sup>1</sup>

**PHYSICAL INJURY** means impairment of physical condition or substantial pain.<sup>2</sup>

Intent means conscious objective or purpose. Thus, a person **INTENTIONALLY** causes physical injury to a person when

that person's conscious objective or purpose is to do so.<sup>3</sup>

In order for you to find the defendant guilty of this crime, the People are required to prove, from all the evidence in the case, beyond a reasonable doubt, both of the following elements:

1. That on or about (date), in the county of (county), the defendant, (defendant's name), intentionally caused physical injury to (specify)
2. That the defendant did so on account of such person or another person having testified in a criminal proceeding.

Therefore, if you find that the People have proven beyond a reasonable doubt both of those elements, you must find the defendant guilty of the crime of Tampering with a Witness in the Second Degree as charged in the \_\_\_\_\_ count.

On the other hand, if you find that the People have not proven beyond a reasonable doubt either one or both of those elements, you must find the defendant not guilty of the crime of Tampering with a Witness in the Second Degree as charged in the \_\_\_\_\_ count.
