## Information on Answering:

What to do if your landlord says you owe rent and you have a court date

If you have received a Notice of Court Date: Rent Not Paid and Petition, you can use this information sheet to tell the court the reasons why you should not be evicted. This is known as an Answer.

You **must** answer the court papers. Take this form with you when you go to court, so you can tell the court clerk or judge about every item you check below.
