**DISTINGUISHING FEATURES OF WORK:** Case Managers I report to the Chief Clerk and Project Director and work in problem solving parts and units. Case Managers I develop treatment plans, determine intervention services, counsel participants and make recommendations to the court. Case Managers I prepare written reports and maintain case files on participants. Case Managers I may also perform other related duties.

**ASSIGNMENT:** This position is assigned to the Nassau County Drug Treatment Court and Opioid Court. Duties include but are not limited to: conducting assessments of defendants for participation in court-monitored substance abuse treatment; submitting detailed recommendations regarding defendants' eligibility to participate in treatment; referring and placing defendants in community-based treatment programs; monitoring defendants' participation in community-based treatment programs; submitting detailed updates to Court and parties regarding treatment participation; and conducting court mandated drug testing. Travel may be required.
