QUALIFICATIONS: Two (2) years of permanent, competitive class service in the NYS Court Officer, Court Officer*, UCO*

title or 1 year of permanent, competitive class service in the NYS Court Officer-Sergeant or Senior

Court Officer* title; or equivalent rank.

Candidates must have: a valid drivers license; full firearms privileges; be able to travel regularly to Pond View (Castleton-on-Hudson) and other off-site locations; be able to participate in rigorous

physical training exercises; completed probation in current title.

ASSIGNMENT: This is an opportunity with the NYS Court Officers Academy to learn and assist with the presentation of in-service and recruit training programs for all court system personnel designated as "peace officers". Under the direction of Court Officer Academy training instructors duties will include, but are not limited to: assisting with providing and presenting training programs in a classroom or other formal training setting through oral instruction, use of training aids, and demonstration of physical techniques; assisting with orientation programs; setting up classroom or skills training area; preparing and maintaining attendance records, evaluation reports and files; maintaining and updating databases; assisting with administering written and skills performance tests; reviewing subject areas and lesson plans; and responding to questions from trainees. Candidates who do not meet performance expectations may return to their court of assignment at anytime during the mentorship program.

Successful completion and exemplary performance in this six month mentorship assignment may lead to appointment as a NYS Court Security Training Officer (JG-20). The program will include monthly evaluation meetings, coaching sessions, and evaluations by the Chief of Court Security Training, Majors and Captains.

They do not include all job duties performed by employees in the title, and every position does not necessarily require these duties.
