## Executive Order No. 111

Revocation of Executive Order No. 111 (Dated March 20, 1987), Which Established an Audit Committee for the City of New York.

WHEREAS, the Audit Committee for the City of New York ("Audit Committee") was originally established and its functions were set forth in Executive Order No. 29, dated February 6, 1979; and

WHEREAS, the Audit Committee was continued by Executive Order No. 111, dated March 20, 1987, which revoked Executive Order No. 29; and

WHEREAS, Executive Order No. 111 specifies that the Audit Committee shall consist of certain City officers and a certain number of private members with specified qualification; and

WHEREAS, the recent Charter revision codified the Audit Committee as part of the New York City Charter and set forth in the Charter the qualifications for the members of the Committee.

By the power vested in me as Mayor of the City of New York, it is hereby ordered:

Section 1. **Prior Order Revoked.** Executive Order No. 111 of March 20, 1987 is hereby revoked and the Audit Committee is continued as set forth in Charter §97.

Section 2. **Effective Date.** This Order shall take effect immediately.
