Executive Order No. 56 February 18, 1981

BY VIRTUE OF THE POWER VESTED IN ME AS MAYOR OF THE CITY OF NEW York, is hereby ordered:

Section 1. Stanley Brezenoff, the Human Resources Administrator, shall succeed to the powers and duties of the Health Services Administrator as specified in Chapter 1016 of the Laws of 1969 (Section 7381 et seq. of the Unconsolidated Laws of New York).

§2. Paragraph (c) of Section 4 of Executive Order No. 41, dated January 16, 1980, is hereby revoked.

§3. This Order shall take effect immediately.

Executive Order No. 57 March 11, 1981

BY THE POWER VESTED IN ME AS MAYOR OF THE CITY OF NEW York, it is hereby ordered:

Section 1. *Prior Order Amended.* Section 4 of Executive Order No. 41, dated January 16, 1980, is hereby amended by adding thereto a new paragraph (c) to read as follows:

“(c) Maintain liaison with and review the activities of the Health and Hospitals Corporation of the City of New York, and succeed to the powers and duties of the “deputy mayor-city administrator of the City” under section 7384 of the Unconsolidated Laws of New York (Chapter 1016 of the Laws of 1969).”

§2. *Prior Order Revoked.* Executive Order No. 56, dated February 18, 1981, is hereby revoked.

§3. This Order shall take effect immediately.
