Upon the foregoing papers, and after a trial before this Court which was held on July 31, 2003, August 1, 2003, August 4, 2003, August 5, 2003, August 6, 2003, August 7, 2003, August 8, 2003, August 11, 2003, August 12, 2003 and August 13, 2003, and for the reasons specified in the Court's oral decision on the record on August 13, 2003, this petition is granted; and it is

**ORDERED, ADJUDGED and DECREED**, that the designating petition filed with the Board of Elections of the City of New York to designate ALLAN W. JENNINGS, JR., candidate-respondent, for the Democratic Party nomination for the Public Office of Council Member from the 28<sup>th</sup> Councilmanic District, Queens County, City of New York, and bearing the identification numbers QN'03 320, QN'03 321, QN'03 322, QN'03 323 is invalid; and it is further

**ORDERED, ADJUDGED and DECREED**, that the Board of Elections of the City of New York is restrained and enjoined from placing the name of ALLAN W. JENNINGS, JR., candidate-respondent, for the Democratic Party nomination for the Public Office of Council Member from the 28<sup>th</sup> Councilmanic District, Queens County, City of New York on the voting machines to be used for the Primary Election to be held on September 9, 2003.
